## Terms and Conditions

- Payment terms:** Net monthly payment by the 30th of the month following the month of invoicing unless a prior arrangement is implemented in writing with management.
- Prices:** All prices quoted are ex GST and are subject to change without notice
- Customers Default:** If payment is not received by the due date, Realport Traders Pty. Ltd. shall be entitled to cancel the customers credit limit and all future orders will be on a COD basis and may also cancel all backorders. All amounts owing to Realport Traders Pty.Ltd will become due for payment immediately.
- Retention Of Title:** Notwithstanding that the risk in the goods shall pass when the customer takes delivery of the goods, ownership is retained by Realport Traders Pty. Ltd until payment is made in full. If the goods are sold by the customer prior to payment or if they become constituents of other goods then the proceeds of the sale shall be the property of Realport Traders Pty. Ltd. Realport Traders Pty. Ltd. shall be given leave to enter at will the property or any premises under the control of the customer if the goods are stored at such premises for the purpose of regaining possession should the customer default in payment.
- Credits:** Authorisation must be obtained before returning goods for credit. No goods will be accepted for credit which are correctly supplied and invoiced if not returned within 14 days. Goods must be in unused condition and in original packaging. A restocking fee may apply.
- Special Orders:** Where the customer places an order for a non stock item, Realport Traders Pty. Ltd will not accept return of non stock items, unless the manufacturer agrees to accept return from Realport Traders Pty. Ltd. Realport Traders Pty. Ltd. may deduct transport, insurance handling and restocking charges from the credit due from the customer.

### DECLARATION

Having read and understood the Terms and Conditions of this agreement and in consideration for Realport Traders Pty. The Applicant/Guarantor/s accept that the giving of this guarantee by us does not obligate Realport Traders Pty. Ltd. to continue to supply goods or services in the event of persistent failure by the Applicant to pay its debts to Realport Traders Pty. Ltd. rights against each Applicant/guarantor/s is not affected by the following:-
